#### MONTHLY USAGE CHARGES

added to the standby charge:

**Monthly Reservoir Surcharge until 2030 \$6.00**

#### Residential

**\$2.34 per ccf (100 cubic feet), up to 800 cubic feet (per share)**

**\$3.78 per ccf for over 800 cubic feet (non stock)**

#### Commercial

**\$2.61 per ccf (100 cubic feet), up to 800 cubic feet (per share)**

**\$4.16 per ccf for over 800 cubic feet (non stock)**

**One (1) unit of water = 100 cubic feet (748 gallons)**

#### MULTIPLE-UNITS:

**Multiple dwelling units include two or more on the same lot such as duplexes, triplex, rear houses, adu, mixed-use, and commercial. The monthly charge for each additional unit is \$10.41 per unit. This is in addition to your monthly meter charge.**
